

ADMISSION AND ENROLLMENT PROCESS 2025/2026 ADMISSION and ENROLMENT PROCESS - UNDERGRADUATE

Student Enrollment into Programs foresee different steps:

STEP 1) Preliminary interview.

We will assess your interests and motivations, discuss your academic background and help you choose the right course.

STEP 2) Send requested documents for the admission.

We will need your ID or Passport, your CV, a motivational letter, if available we will also need a Portfolio and a Language certificate. Further documents such as previous academic qualifications or statement of family income for EU students will be required later.

STEP 3) Interview with the program Director.

We will let you meet with the course leader, the scientific director or a member of the faculty. The online interview will revolve around your submitted documents and will include a language assessment, if necessary.

STEP 4) Welcome to the Raffles family.

We will send you the Admission Certificate (upon request), Enrollment Form and Payment Details Form so that you can complete the paperwork. You will receive Enrollment Certificate (and VISA kit, if applicable) after completing the payment of the Enrollment Fee. You will also receive a payment plan for the Tuition fees.

For all Bachelor courses (M.U.R. Accredited) the payment of Regional Fee of € 140,00 shall be paid in addition to the above fees.

For all Bachelor and 3 Years courses, the above Fee is for the 1st year of enrollment, the fee schedule will be applicable for all 3 years of the course. All fee reductions will be re-evaluated every year based on their own eligibility conditions. The above-mentioned fees are inclusive of VAT for the students, if applicable.

The tuition fees **do not cover** the following Miscellaneous fees, as the case may be: Academic overheads costs, Processing Fee for Defer/Transfer, For Inter-School Transfer, Re-Issue of Certificate, Re-Issue of Transcript/Letter of Certification, Re-Taking of Module Fee, Late Payment Charges

<u>All EU students</u> who are eligible can submit ISEE Università or ISEE Parificato for fee waivers based on their household income and assets declarations. <u>In order to be eligible, EU students must be a Citizen</u> of an EU member state, and they and their family must reside in the EU and their family income and <u>assets must be based in the EU.</u> Italian students can approach the relevant authorities for issuance of their ISEE Università.

EU Students must apply for and obtain "Equivalent" ("ISEE Parificato") as if they are not resident in Italy, and in the case that they are resident in Italy, but not financially independent from their EU-based family. The ISEE Parificato received from. Reciprocating EU member state must include declaration from the family members, and be issued or ratified by INPS, Italy. All other proof of household income will not be accepted.
