ADMISSION and ENROLMENT PROCESS - UNDERGRADUATE

Student Enrollment into Programs foresee different steps:

STEP 1) Preliminary interview	We will assess your interests and motivations, discuss your academic background and help you choose the right course.		
STEP 2) Send requested documents for the admission.	We will need your <ul style="list-style-type: none"> - ID or Passport - your CV - a motivational letter 	and, if available we will also need <ul style="list-style-type: none"> - a Portfolio - a Language certificate 	Further documents will be required later such as <ul style="list-style-type: none"> - previous academic qualifications - statement of family income for EU students (ISEEU)
STEP 3) Interview with the program Director.	We will let you meet with the course leader, the scientific director or a member of the faculty. The online interview will revolve around your submitted documents and will include a language assessment, if necessary.		
STEP 4) Welcome to the Raffles family.	We will send you the Admission Certificate (upon request), Enrollment Form and Payment Details Form so that you can complete the paperwork. You will receive Enrollment Certificate after completing the payment of the Enrollment Fee. You will also receive a payment plan for the Tuition fees.

*Accreditation from the Italian Ministry of University and Research (MUR) D.M. n.1216 del 31.08.2023, in accordance with the system of Advanced Artistic, Musical and Coreutico Education (AFAM). For all Bachelor courses (M.U.R. Accredited) the payment of Regional Fee up to **€ 190,00** shall be paid in addition to the above fees.

For ITA and EU students enrolling in Bachelor courses (M.U.R. Accredited), the annual ISEE-based Tuition Fee waivers by Income Brackets, are subject to application and documents submission.

All EU students who are eligible can submit ISEE Università or ISEE Parificato for fee waivers based on their household income and assets declarations. All other proof of household income will not be accepted. In order to be eligible, students and their family must be resident in EU or Italy, and derive their family income (and assets) in the EU or Italy. Students who apply for residency on an individual basis, whose family income and assets is derived in non-EU member states, are not eligible for ISEEU benefits. Italian students can approach the relevant authorities for issuance of their ISEE Università.

TUITION FEES CAN BE PAID IN ONE SOLUTION WITH THE ENROLLMENT FEE OR A PAYMENT PLAN CAN BE SET.

The total amount due (inclusive of discounts and/or scholarships if available) will be calculated at the moment of Admission and communicated in a personalized Payment Details form. All fee reductions will be re-evaluated every year based on their own eligibility conditions.

The above-mentioned fees are inclusive of VAT for the students, if applicable.

The tuition fees do not cover the following Miscellaneous fees, as the case may be:

Academic overheads costs, Processing Fee for Defer/Transfer, For Inter-School Transfer, Re-Issue of Certificate, Re-Issue of Transcript/Letter of Certification, Re-Taking of Module Fee, Late Payment Charges

For all Bachelor and 3 Years courses, the above-mentioned fees and deadlines are for the 1st year of enrollment. For the following years the payment plan below will be applied
