ART. 1 — SUBJECT, PURPOSE AND REGULATORY FRAMEWORK

1.1 Subject

Raffles Milano International Design Institute, through its Registrar's Office (Segreteria Amministrativa e Studenti — SAS Office), announces this call for the award of scholarships for the right to university education for the academic year 2026/2027, for students enrolled in the First-Level Academic Diploma (Diploma Accademico di Primo Livello) programmes.

1.2 Purpose

Raffles Milano, as an AFAM Institution accredited by the Ministry of University and Research pursuant to Ministerial Decree (D.M.) no. 1216 of 31 August 2023, coordinates and disburses to students the measures and services aimed at implementing the right to education provided for by Lombardy Regional Law (L.R.) no. 33 of 13 December 2004, as well as any further measure intended to secure the best study conditions.

1.3 Regulatory framework

This Call is issued in accordance with:

- Legislative Decree (D.Lgs.) no. 68 of 29 March 2012, «Revision of the framework legislation on the right to education and enhancement of legally recognised university colleges», with particular reference to arts. 7, 8 and 10;
- Prime Ministerial Decree (D.P.C.M.) of 9 April 2001, «Provisions for uniform treatment of the right to university education», for the parts not repealed;
- Prime Ministerial Decree (D.P.C.M.) no. 159 of 5 December 2013, «Regulation concerning the revision of the methods of determination and the fields of application of the Equivalent Economic Situation Indicator (ISEE)», with particular reference to arts. 3, 8 and 9;
- **Ministerial Decree (D.M. MUR) no. 1320 of 17 December 2021**, «Increase in the value of scholarships and eligibility requirements for right-to-education benefits», with particular reference to art. 5 (merit requirements) and art. 3 (amounts), which constitutes an **essential level of provision (livello essenziale delle prestazioni) pursuant to art. 117, paragraph 2, letter m) of the Constitution**;
- MUR Circular no. 13676 of 11 May 2022, setting out application details for D.M. no. 1320/2021;
- **Directorial Decree (D.D. MUR) no. 175 of 10 February 2026**, updating the minimum scholarship amounts for a.y. 2026/2027;
- **Directorial Decree (D.D. MUR) no. 176 of 10 February 2026**, updating the maximum ISEE and ISPE limits for a.y. 2026/2027;
- Ministerial Decree (D.M. MUR) no. 933 of 2 August 2022, implementing Law no. 33 of 12 April 2022, on simultaneous enrolment in two study programmes at AFAM Institutions and Universities;
- Lombardy Regional Law (L.R.) no. 33 of 13 December 2004, «Rules on regional measures for the right to university education»;
- Regional Government Resolution (D.G.R.) Lombardy Region no. **6298**, setting out determinations regarding the criteria and funding forecasts for the award of the benefits offered for the right to university education;
- Ministerial Decree (D.M. MUR) no. **176 of 24/02/2026** setting out the definition of the list of particularly poor countries for a.y. 2026/2027;
- Presidential Decree (D.P.R.) no. 445 of 28 December 2000, «Consolidated act of legislative and regulatory provisions on administrative documentation»;

- Legislative Decree (D.Lgs.) no. 286 of 25 July 1998 (Consolidated Immigration Act) and Presidential Decree (D.P.R.) no. 394 of 31 August 1999 (implementing regulation), with particular reference to art. 46, paragraph 5;
- Regulation (EU) 2016/679 (GDPR);
- Regulation (EU) 2016/1191, on promoting the free movement of certain public documents within the European Union;
- Law no. 241 of 7 August 1990, on administrative procedure.

1.4 Sources of funding

The scholarships are funded by: the Lombardy Region's own resources; revenue from the regional tax for the right to university education (Law 549/1995, art. 3, paragraphs 20-23); and resources of the State Supplementary Fund (Fondo Integrativo Statale, FIS) allocated by the Ministry of University and Research pursuant to art. 18 of D.Lgs. 68/2012. The minimum funding forecast for Raffles Milano is quantified in Annex B to D.G.R. no. 6298/2026.

1.5 Person in charge of the procedure

ART. 2 — PARAMETER FRAMEWORK (SINGLE SOURCE OF TRUTH)

All numerical values referred to in this Call derive exclusively from the tables in this article. In the event of a discrepancy between a value indicated elsewhere in the text and the value shown in this article, **the value in this article prevails**.

2.1 Economic access thresholds

Pursuant to D.G.R. Lombardy no. 6298/2026, for a.y. 2026/2027 the maximum limits are as follows. Both limits must be met jointly: exceeding even one of them results in ineligibility.

2.3 Scholarship amounts

The amounts are set by D.G.R. Lombardy no. 6298/2026, Annex A, point 1, and include the reimbursement of the regional tax for the right to education and the portion relating to the catering service. Since Raffles Milano does not have its own catering service, the portion corresponding to the catering withholding — equal to € 829.00 for a.y. 2026/2027 — is disbursed in cash to the student, as expressly permitted by the same D.G.R. The amounts shown in the table below are therefore inclusive of this portion. The net amounts (before the catering portion) set by D.D. MUR no. 175 of 10 February 2026 and adopted by the D.G.R. are: on-site € 2,601.00; commuter € 3,991.00; off-site € 7,419.00.

2.3.1 Scholarship supplements

Pursuant to point 2 of Annex A to D.G.R. Lombardy no. 6298/2026 and the corresponding provisions of D.M. MUR no. 1320/2021, the following supplements are provided for, awarded within the limits of the available funding and in the following order of priority:

a) Female students enrolled in STEM programmes — 20% increase (art. 3, paragraph 5, D.M. 1320/2021). This increase is not cumulative with the 15% provided for students with an ISEE below 50% of the maximum limit.

b) Dual enrolment — 20% increase (art. 6, paragraph 3, D.M. 1320/2021), provided that the student holds and maintains the merit requirements for both programmes for their entire duration (art. 5.4 of this Call).

c) Degree-completion award — a supplement equal to half the scholarship received in the final year of the programme, net of service withholdings, for students who obtain the Academic Diploma within the duration set by the study regulations (art. 2, paragraph 3, D.M. 1320/2021).

d) Students with disabilities — increase of up to 40% of the amount due, according to the disability, in order to allow the use of prostheses and aids (point 5 of Annex A to the D.G.R.).

e) International mobility and internships — a contribution of € 600.00 per month for the duration of the stay abroad, up to a maximum of ten months, in addition to the reimbursement of travel expenses up to € 100.00 (European countries) or € 500.00 (non-European countries). The contribution is granted only once for the entire study path (point 6 of Annex A to the D.G.R.).

f) ISEE equal to or below half the maximum limit (€ 13,443.96) — 15% increase of the amount (art. 3, paragraph 3, D.M. 1320/2021).

2.4 Merit requirements

The merit requirements are those set by art. 5 of D.M. MUR no. 1320/2021. Since the First-Level Academic Diploma programmes of Raffles Milano provide for 60 CFA per year (180 in total), the re-proportioning under art. 5, paragraph 12 of the same decree does not apply.

2.6 Number of scholarships offered

Scholarships are awarded in ranking order, until the available resources are exhausted. The minimum funding forecast assigned to Raffles Milano International Design Institute for a.y. 2026/2027 is € 11,155.69 (D.G.R. Lombardy no. 6298/2026, Annex B). The number of scholarships actually payable depends on the geographic status and income bracket of the recipients and therefore cannot be predetermined. This amount may be increased in the event of additional appropriations by the Lombardy Region or the MUR, or of carry-overs from previous years.

ART. 4 — DEFINITIONS

For the purposes of this Call, the following definitions apply:

Term	Definition
Eligible (Idoneo)	A student who holds all the merit and income requirements set out in this Call.
Eligible recipient (Idoneo assegnatario)	An eligible student who, based on their ranking position, is a scholarship recipient.
Eligible non-recipient (Idoneo non assegnatario)	An eligible student who is not a scholarship recipient because the available resources have been exhausted.
Not eligible (Non idoneo)	A student who does not hold one or more of the required requirements.
First-ever enrolment (Prima immatricolazione assoluta)	The academic year of the very first enrolment in any study programme of the same level, at any AFAM Institution or University, Italian or foreign, regardless of the outcome of that career (withdrawal, lapse, transfer, attainment of the qualification, etc.).
CFA	Academic Training Credit (Credito Formativo Accademico), the unit of measurement of learning workload in the AFAM system, equivalent to the university CFU. In this Call the terms CFA and CFU are used as synonyms.
ISEE	Equivalent Economic Situation Indicator, in the specific version for subsidised benefits for the right to university education.
ISPE	Equivalent Asset Situation Indicator, corresponding to the ratio of ISP (Asset Situation Indicator) to the equivalence scale.
ISR	Income Situation Indicator.
DSU	Single Substitute Declaration (Dichiarazione Sostitutiva Unica), a self-declaration pursuant to D.P.R. 445/2000 on the basis of which INPS issues the ISEE certificate.
Equivalent ISEE (ISEE parificato)	An indicator calculated, for students whose family unit resides abroad, on the basis of the foreign documentation produced at an affiliated CAF, pursuant to art. 8, paragraph 5 of D.P.C.M. 159/2013.
Bonus	An allocation of virtual credits usable, in addition to the credits actually obtained, to meet the merit requirements, in the manner set out in art. 7.4.
On-site student (Studente in sede)	A student resident in the Municipality where the programme is located or in Municipalities from which the travel time by public transport does not exceed 60 minutes.
Commuter student (Studente pendolare)	A student resident in Municipalities from which the travel time by public transport is between 61 and 90 minutes.
Off-site student (Studente fuori sede)	A student resident in Municipalities from which the travel time by public transport exceeds 90 minutes and who, for that reason, takes paid accommodation near the programme location for a period of no less than 10 months.
Repeat year (Ripetenza)	Enrolment in a year of the programme in which the student was already enrolled, regardless of the time elapsed and the outcome of the previous career.
Suspension of studies (Sospensione degli studi)	A formally authorised interruption of the academic career. Years of suspension are not counted for the purpose of calculating the merit requirements.

ART. 5 — ELIGIBLE APPLICANTS AND CONDITIONS OF PARTICIPATION

5.1 Eligible persons

The following may participate in the competition:

- Italian students;
- students who are citizens of European Union Member States;
- students who are citizens of non-EU States, lawfully resident in Italy, pursuant to art. 46, paragraph 5 of Presidential Decree no. 394 of 31 August 1999, implementing Legislative Decree no. 286 of 25 July 1998;
- **students holding international protection (refugee status or subsidiary protection) or special protection**, as provided for by art. 10.6.

Applicants must be enrolled, or declare their intention to enrol, for a.y. 2026/2027 in one of the First-Level Academic Diploma programmes of Raffles Milano.

5.2 Grounds for exclusion

Students may not participate in the competition if, in a.y. 2026/2027, they:

- already hold a qualification, obtained in Italy or abroad — including qualifications without legal value in Italy — of a level equal to or higher than the programme for which the scholarship is requested;
- benefit, for the same year of the programme, from a scholarship or similar form of financial aid disbursed by Raffles Milano or by any public or private, national or foreign body, subject to the exceptions in art. 12.1;
- enrol in a year of the programme, of the same study level, in which they were already enrolled, regardless of the time elapsed and the outcome of the previous career;
- are enrolled in a repeat year;
- are enrolled in programmes without the recognition of training credits;
- are enrolled as off-track (fuori corso) students.

5.3 Valid enrolment

To be admitted to the rankings, applicants must be duly enrolled for a.y. 2026/2027 by the deadline in art. 3. A student is deemed duly enrolled where the tuition fee and course contribution are **paid and recorded in the financial position** by the same deadline.

5.4 Dual enrolment

Pursuant to Law no. 33 of 12 April 2022 and D.M. MUR no. 933/2022, a student enrolled simultaneously in two study programmes benefits from the right-to-education instruments and services for one enrolment only, indicated by the student in the application.

Pursuant to art. 6 of D.M. no. 933/2022, a student already enrolled in a study programme in years after the first may not designate the second enrolment as the reference for right-to-education benefits.

Pursuant to art. 6, paragraph 3 of D.M. MUR no. 1320/2021, a student with dual enrolment is entitled to a 20% increase in the scholarship amount, **provided that they maintain the merit requirements for both programmes** for their entire duration. The increase is not due where the student loses the requirements with respect to the programme to which the increase was linked.

Failure to declare, or false declaration of, dual enrolment results in forfeiture of the scholarship and application of the penalties in art. 10, paragraph 3 of D.Lgs. 68/2012.

ART. 6 — MERIT REQUIREMENTS

6.1 Students enrolled in the 1st year

Access to the ranking requires:

- first-ever enrolment in the 1st year of the programme;
- an upper secondary school diploma with a grade equal to or higher than **85/100**.

The minimum diploma-grade requirement is set in implementation of point 7, letter b) of Annex A to D.G.R. Lombardy no. 6298/2026, which makes access to benefits for first-year students conditional on passing the minimum-knowledge assessment without additional training obligations (OFA), or — as an alternative left to the managing body — on obtaining a school-leaving grade of no less than 70/100. Raffles Milano exercises this option and sets the threshold at 85/100, a value higher than the regional minimum and therefore fully legitimate.

For qualifications obtained abroad, where the grade is expressed in qualitative terms, it must correspond at least to a rating of «good» on a scale from «sufficient» to «excellent». The official translation of the qualification must state the correspondence of the rating. Alternatively, conversion is permitted on the basis of the Declaration of Value (Dichiarazione di Valore) or the CIMEA comparability statement.

Ex-post merit requirement. Pursuant to point 7, letter c) of Annex A to D.G.R. Lombardy no. 6298/2026, the student enrolled in the 1st year must obtain **at least 35 CFA**:

- **by 10 August 2027**, for the disbursement of the second instalment.
- **by 30 November 2027**, for the retention of the first instalment. Failure to obtain them by that deadline results in revocation of the scholarship.

The bonus under art. 6.4 may be used, up to a maximum of 5 CFA, to reach the 35 CFA.

6.2 Students enrolled in the 2nd year

The student must have obtained **at least 35 CFA by 10 August 2026**, and have met any additional training obligations set at the time of admission to the programme. A bonus of up to a maximum of 5 CFA may be used.

6.3 Students enrolled in the 3rd year

The student must have obtained **at least 80 CFA by 10 August 2026**. A bonus of up to a maximum of 12 CFA may be used.

6.4 Bonus

Pursuant to art. 5, paragraph 7 of D.M. MUR no. 1320/2021, a student who has not obtained the minimum number of credits required may use, in addition to the credits actually obtained, a bonus as follows:

Use	Maximum bonus
First time, for access to 2nd-year benefits	5 CFA
First time, for access to 3rd-year benefits	12 CFA

- The bonus may be used only once during the studies and is not cumulative.
- The portion of bonus not used in the relevant academic year may be used in subsequent years.

- The bonus accrued and not used during the First-Level Academic Diploma programme may be used in the event of enrolment in a Second-Level Academic Diploma programme.
- The bonus **may not be used** to reach the 35 CFA requirement set for the 1st year.

6.5 Students with disabilities

For students with recognised handicap pursuant to art. 3, paragraph 1 of Law no. 104 of 5 February 1992, or with invalidity equal to or greater than 66% — the categories referred to in art. 1, paragraph 1, letter g) of D.M. 1320/2021 — the merit requirements are reduced by a maximum of 40%, as per the following table:

Year of enrolment	Ordinary requirement	Reduced requirement (–40%)
1st year — diploma grade	85/100	51/100
1st year — ex-post requirement	35 CFA	21 CFA
2nd year	35 CFA	21 CFA
3rd year	80 CFA	48 CFA

The reduction operates automatically, upon submission of the certification referred to in art. 9.2. No request by the student and no discretionary determination are required.

The provisions on revocation for failure to meet the ex-post merit requirement do not apply to the students referred to in this paragraph.

The students referred to in this paragraph, if included in the eligibility ranking, are entitled to the award of the scholarship even in excess of the number of scholarships available and have priority in the ranking over other students.

6.6 Validity of credits

- Credits from exams taken and duly recorded from the start of the career, for the current study level, and by the deadline in art. 3 are countable.
- Exams with a grade not expressed out of thirty are also valid.
- Credits from out-of-plan exams, from individual in-progress modules, or from exams taken and recorded before enrolment in the current study level are not countable, even if recognised and included in the study plan.
- Years of formally authorised suspension of studies are not counted for the purpose of determining the reference year for the merit requirements.

6.7 Weighted average

The weighted average is calculated only on exams graded out of thirty. Honours (lode) are counted as 31. The average is rounded to two decimal places.

Formula: each grade is multiplied by the number of credits of the exam; the sum of the products is divided by the total credits considered.

Weighted average = 756 / 30 = 25,20

ART. 7 — INCOME REQUIREMENTS

7.1 Access thresholds

Students must jointly hold the ISEE and ISPE values referred to in art. 2.1, based on an ISEE certificate issued in 2026.

For a.y. 2026/2027, the reference income is that of calendar year **2024**; assets, both movable and immovable, are those held as at **31 December 2024**.

7.2 ISEE certificate and DSU

The ISEE certificate must bear, **on pain of inadmissibility of the application**, the wording concerning its applicability to subsidised benefits for the Right to University Education in favour of the applicant student (identified by tax code).

Signing a full DSU is mandatory: the mini DSU alone is in no case accepted. A full DSU requested for social-assistance benefits or for minors is not valid.

The person signing the DSU is civilly and criminally liable for the correctness and completeness of the data it contains, pursuant to arts. 75 and 76 of D.P.R. 445/2000.

Applicants are advised to obtain the certificate promptly: average issuance times are about seven working days, which may increase for a non-independent student.

7.3 ISEE with omissions or discrepancies

Pursuant to the note of the Ministry of Labour and Social Policies of 26 October 2020, no. 8415, certificates bearing the wording «ISEE with omissions/discrepancies» are accepted at the time of application.

Raffles Milano will subsequently request — including before publication of the provisional or final ranking — appropriate documentation regarding such omissions or discrepancies, reserving the right to declare the student ineligible where the supplementary documentation is incomplete or reveals omissions with respect to the certified values.

7.4 Current ISEE (ISEE corrente)

Pursuant to art. 9 of D.P.C.M. 159/2013, a current ISEE may be requested, even where a valid ordinary ISEE exists, upon a change in employment situation, an interruption of social-security, welfare or indemnity benefits not included in total income, or a reduction of more than 25% in the family unit's overall income capacity.

A student holding a current ISEE must attach a copy of it, together with the reference ordinary ISEE and the related DSU.

7.5 Composition of the family unit

The family unit is defined pursuant to art. 3 of D.P.C.M. 159/2013. With reference to the date of signing the DSU, it always comprises:

- the applicant student;
- all persons appearing in the applicant's family-status record, even if not linked by kinship or affinity, with the exception of adults, unmarried and childless, who are 100% fiscally dependent on their own parents, the latter being outside the student's registry unit;
- the applicant's brothers and sisters, adults, unmarried and childless, not appearing in the student's family-status record but 100% fiscally dependent on the parents;
- any minors in pre-adoptive foster care with members of the registry unit as at the date of signing the DSU;
- where the conditions of independent student do not apply, both parents of the applicant — whether married to each other or never married — even if they have a registry residence different from that of the student.

NOTE: the fiscal dependency is assessed with reference to the year in which the income was produced (**2024**) and not with reference to the time of signing the DSU.

7.6 Independent student

A student who does not reside with either parent may declare themselves independent of the family unit of origin only if both of the following requirements are met:

- residence, as shown by registry records, outside the housing unit of the family of origin, established for at least two years as at the application submission date and in a property not owned by a member of the family unit of origin;
- own income from employment or equivalent, not performed as an employee of a family member, fiscally declared in the last two calendar years preceding the application, of no less than € 9,000.00 for each year.

In the absence of one or both requirements, the student is integrated into the parents' unit.

The independent-student condition also applies to a married student; in that case the € 9,000.00 threshold is deemed reached also by counting the spouse's income.

7.7 Special cases

Parents never married to each other

Both parents contribute to forming the unit. Where the parent not living with the student is married to a person other than the other parent, or has children with a person other than the other parent, they are treated according to the «additional component» mechanism in Annex 2, paragraph 2 of D.P.C.M. 159/2013.

Legally separated or divorced parents

A non-independent student is part of the unit of the parent with whom they form a family-status record. In the case of a judgment issued abroad, it must be annotated or transcribed in the Italian Municipality of residence.

Where the student has a registry residence separate from both parents, they form a unit:

- with the parent who had them 100% fiscally dependent in the year the relevant income was produced;
- or, in the case of shared fiscal dependency, with a parent of their choice;
- in the absence of fiscal dependency, with the parent to whom the judgment assigns the receipt of maintenance payments; failing that, arts. 433 and 441 of the Civil Code apply.

Student orphaned of both parents

The unit is that resulting from the registry family-status record.

7.8 Changes in the family unit

Changes entailing corrections to an ISEE certificate already submitted are assessed only if the event that caused them occurred by the application submission deadline and the new ISEE is submitted by the deadline for appeals against the provisional ranking.

ART. 8 — GEOGRAPHIC STATUS

8.1 Definitions

Pursuant to art. 4, paragraph 8 of D.P.C.M. of 9 April 2001, the geographic status is determined by the travel time by public transport from the Municipality of residence to the programme location:

Status	Travel time	Further condition
On-site	up to 60 minutes	—
Commuter	from 61 to 90 minutes	—
Off-site	over 90 minutes	paid accommodation near the location for no less than 10 months

A student resident in the Municipality of Milan is in any case considered **an on-site student**, as it is the Municipality where the programme is located.

In the absence of the paid-accommodation condition, the off-site student is reclassified as a commuter.

An independent student is also considered off-site if they use paid accommodation in the Municipality where the programme is located.

8.2 Determination of travel time

Travel times can be verified on the regional portal www.muoversi.regione.lombardia.it and, for Municipalities outside the Lombardy Region, using the tools employed by the right-to-education managing bodies.

Annexes A and B provide, for purely indicative purposes, the list of Municipalities classified respectively as commuter and off-site. **In the event of a discrepancy between the annexed lists and the actual travel time detectable on the regional portal, the time-based criterion prevails** under art. 4, paragraph 8 of D.P.C.M. of 9 April 2001. Municipalities not listed are classified on the basis of the same criterion.

8.3 Paid accommodation

«Paid» means the existence of:

- a rental contract duly registered with the Revenue Agency (Agenzia delle Entrate), validated for the current year through payment via form F24 or F23, in the name of the student or a member of their unit. In the case of subletting, a copy of the original rental contract and the related registration receipt must also be produced;
- for students domiciled in collective facilities, a fiscally valid certification attesting payment of the rent for the accommodation used in the Municipality where the programme is located.

The documentation must be received at chiararomaniello@rafflesmilano.it — sahrayaqub@rafflesmilano.it by the deadline in art. 3. Failure to send, or incomplete sending, by that deadline results in the student's reclassification as a commuter.

Where the documentation has already been produced and no changes have occurred, it is sufficient to send, by the same deadline, a self-declaration confirming the contract data, indicating the registration details and accompanied — where the contract is not subject to the flat-rate tax (cedolare secca) regime — by a copy of the payment to the Revenue Agency for the annual renewal.

ART. 9 — SUBMISSION OF THE APPLICATION

9.1 Deadlines and procedures

The application must be submitted, on pain of exclusion, by the deadline in art. 3, in the manner indicated at <https://rafflesmilano.it/scholarship/>.

9.2 Documents required from all applicants

- a completed and signed admission application;
- a double-sided copy of a valid identity document of the student (and of the parent or person exercising parental responsibility, in the case of a minor student);
- upper secondary school diploma;
- ISEE certificate for subsidised benefits for the right to university education, issued in 2026;
- the related DSU in extended version, signed by the declarant in every part;
- a copy of the receipt of payment of the tuition fee for a.y. 2026/2027;
- for students enrolled in years after the first: certification or self-certification of the exams taken, indicating the CFA obtained and the grades achieved.

9.3 Documents required in specific cases

Failure to submit a document by the prescribed deadline, or submission of an irregular document, results in exclusion from the competition.

ART. 10 — INTERNATIONAL STUDENTS AND INCOME EARNED ABROAD

10.1 Scope

This article applies to all students — of any citizenship, including Italian citizens resident abroad — whose family unit holds assets as at 31 December 2024 or earned income in 2024 in countries other than Italy.

10.2 General principle

The ISEE information system does not allow the calculation of the economic situation of family-unit members resident abroad. Assessment is therefore carried out by means of an equivalent ISEE, calculated on the basis of the foreign documentation produced at an affiliated CAF.

Self-certification of foreign income or assets is not permitted, except as provided for in paragraphs 10.5 and 10.6.

A student with income or assets abroad is nonetheless required to declare any income and assets held in Italy by any member of their family unit, and to produce the related ISEE certificate.

Assets and income produced outside the euro area are valued on the basis of the 2024 average exchange rate.

The documentation must be produced even if it has already been partially submitted in previous years or to other offices of the Institution.

Special case — Bulgaria

For buildings located in Bulgaria, given that the cadastral documentation is issued on a provincial rather than national basis, each adult member must produce, in addition to the 31.12.2024 record, also the general national computerised movement history issued by IKAR.

Special case — Albania

For each adult member, two separate documents on the existence or otherwise of income in 2024 must be produced: the first issued by the Social Insurance Institute (Instituti i Sigurimeve Shoqërorë), on income from employment or pension; the second issued by the Ministry of Finance, on self-employment income.

10.4 Translation and legalisation

The documentation must be issued by the competent authorities of the country where the income was produced and the assets are held, translated into Italian and legalised according to the regime applicable to the issuing country.

New compared to the 25/26 Call. The **Regulation (EU) 2016/1191**, applicable from 16 February 2019, exempts from legalisation and apostille public documents relating, among other things, to birth, residence and family status issued in one Member State and presented in another Member State, and provides for the use of multilingual standard forms. The 2025/2026 Call did not take it into account, requiring the apostille also for EU documents that are exempt from it.

Special cases of legalisation

- Sweden and the Republic of Moldova: signatories to the London Convention of 1968. Only documents issued by the diplomatic and consular authorities present on Italian territory are exempt from legalisation.
- Albania: since 1 July 2011, Albanian documents do not require legalisation at the Italian diplomatic-consular missions in Albania, but must bear the Apostille stamp affixed by the Albanian Ministry of Foreign Affairs.
- Where there are proven difficulties in obtaining the certification in the country of origin, it may be issued by the foreign diplomatic or consular mission in Italy and legalised by the territorially competent Prefecture, pursuant to art. 33 of D.P.R. 445/2000. The consular declaration must expressly refer to the documents originating from the country of origin, which must in any case be translated and produced in copy.

Annex C provides the list of countries with an indication of the group to which they belong. Countries not listed fall within group D. **In the event of a discrepancy between Annex C and the applicable law, the latter prevails.**

10.5 Students from low-human-development countries

For students from countries identified as particularly poor by **D.M. no. 176 of 24/02/2026**, the economic situation is assessed on the basis of a certification from the Italian mission in the country of origin, attesting that the student does not belong to a family notoriously of high income and high social status.

Such certification may also be issued by Italian bodies authorised to provide guarantees of economic coverage under the applicable provisions on the enrolment of foreign students. In that case, the certifying body must accompany the certification with a written undertaking to repay the scholarship on the student's behalf in the event of revocation.

10.6 Students holding international protection

For students recognised as refugees, holders of subsidiary protection or stateless persons, for the purpose of assessing the economic situation **only income and assets held in Italy are taken into account**. No documentation relating to the country of origin is required.

The ISEE certificate referring to the family unit, accompanied by a copy of the status recognition decision, is sufficient.

10.7 Minimum income for non-EU students

The income of students from non-EU countries may not be lower than **7.002,97**, corresponding to the minimum means of subsistence to be proven for the purpose of applying for an entry visa to Italy for study reasons. This amount constitutes the minimum ISR value.

ART. 11 — FORMATION OF THE RANKINGS

11.1 Students enrolled in the 1st year

The ranking is drawn up exclusively on the basis of the family unit's ISEE, in relation to the maximum limit in art. 2.1, up to a maximum of 1,000 points, according to the following formula:

$$\text{Score} = (1 - \text{student ISEE} / 26,887.93) \times 1,000$$

where 26.887,93 is the maximum ISEE limit in art. 2.1

The ranking order is determined in descending order of score. In the event of a tie, the higher grade of the qualification giving access prevails; in the event of a further tie, the younger applicant prevails.

11.2 Students enrolled in years after the first

The ranking order is determined in descending order of the overall score, equal to the sum of two components, up to a maximum of 1,000 points:

Component	Maximum points
Training credits obtained	600
Weighted average grade of exams passed	400
TOTAL	1.000

Credits component (max 600 points)

$$P_1 = (\text{student CFA} - \text{minimum CFA}) / (\text{maximum CFA} - \text{minimum CFA}) \times 600$$

2nd year: minimum CFA = 35 · maximum CFA = 60

3rd year: minimum CFA = 80 · maximum CFA = 120

The value of P_1 may not be less than 0 or greater than 600.

Average component (max 400 points)

$$P_2 = (\text{weighted average} - 18) / (31 - 18) \times 400$$

where 18 is the minimum passing grade and 31 the value attributed to honours (lode).

$$\text{Overall score} = P_1 + P_2$$

11.3 Priority criteria

- In the event of a tie in merit score, the student who has not used the bonus takes precedence.
- In the event of a further tie, the student with the higher income score takes precedence.
- In the event of a further tie, the younger student takes precedence.
- Students with disabilities under art. 6.5, if included in the eligibility ranking, **are entitled to the award of the scholarship even in excess of the number of scholarships available and have priority in the ranking over other students.**

11.4 Outcome

Students who submit an application may be found eligible or not eligible. Benefits are awarded to eligible students in ranking order, until the available resources are exhausted. Eligible non-recipient students may obtain the benefit at a later time, should further resources become available.

In the event of a shortage of recipient students in one ranking, the remaining scholarships are awarded to students suitably placed in another ranking, up to completion of the established number of scholarships.

11.5 Publication and appeals

The provisional and final rankings are published, on the dates in art. 3, at <https://rafflesmilano.it/scholarship/>.

Appeals against the provisional ranking must be submitted to the Registrar's Office - SAS Office within 15 days of publication. The appeal must concern erroneous assessments by the Office and be accompanied by documentation suitable to justify its grounds.

The outcome of appeals is communicated by e-mail. Once the procedure is complete, the final ranking is published.

ART. 12 — DISBURSEMENT, INCOMPATIBILITY, FORFEITURE AND REVOCATION

12.1 Disbursement procedures

The scholarship is disbursed in two instalments, according to the timeline in art. 3, subject to the transfer of funds by the Lombardy Region.

Disbursement is made exclusively by bank transfer to a current account in Italy or in a SEPA-area country, held or co-held by the recipient student. Credit cards and rechargeable prepaid cards are excluded.

If the student does not provide a valid IBAN within one year of publication of the final ranking, the possibility of receiving the disbursement lapses. Amounts not collected flow into the scholarship funds for the following academic year.

12.2 Incompatibility

The scholarship is not cumulative with similar forms of financial aid disbursed by Raffles Milano or by other public or private bodies. In such cases the student may choose one or the other benefit. The following are unaffected:

- scholarships granted by national or foreign institutions to supplement training or research activities with stays abroad;
- award-based contributions assigned to students enrolled in excellence programmes.

12.3 Revocation

The scholarship is revoked in the following cases:

12.3.1 Revocation for failure to meet the payment deadlines for enrolment in the following year

A scholarship recipient is required to meet the payment deadlines set for finalising enrolment in the following academic year, as established by the study regulations and the enrolment contract.

Failure to meet these deadlines results in revocation of the scholarship.

Before adopting the revocation measure, the Student and Administration Office - SAS sends the student, at the institutional e-mail address, a notice of commencement of the procedure pursuant to art. 7 of Law 241/1990, granting a period of no less than **15** days to regularise their position or submit observations.

If that period elapses without result, revocation is ordered by reasoned measure, communicated to the student, with application of the effects in art. 12.5.

12.4 Forfeiture

The right to the scholarship lapses if the student:

- incurs disciplinary sanctions higher than a written warning, for infractions committed against the Registrar's Office - SAS Office or Raffles Milano;
- fails to submit to the Registrar's Office - SAS Office, within the indicated deadlines, the original documentation required to verify the truthfulness of the self-certifications produced;
- obtains the academic qualification before the end of the relevant academic year, subject to the provisions for students who obtain the qualification within the legal duration of the programme.

12.5 Effects of revocation

In the event of revocation, the sums collected and the amount corresponding to the value of the services actually enjoyed, equivalent to the scholarship in cash, **must be repaid**.

Upon reasoned request by the student, the Registrar's Office - SAS Office may grant repayment in instalments.

Until the sums due are fully repaid, the student may not request any further benefit from Raffles Milano.

The provisions on revocation for failure to meet the ex-post merit requirement and on payment of the second instalment do not apply to students with disabilities under art. 6.5.

ART. 13 — TRANSFERS

In the case of transfer to another AFAM Institution or University after the start of the academic year, the application submitted to the Registrar's Office - SAS Office is forwarded to the new competent managing body and the student forfeits the benefit previously granted, with an obligation to repay any instalments collected.

A student who transfers to Raffles Milano from another Institution after the start of the academic year must ask the managing body of origin to forward the application ex officio, provided it was submitted within the deadlines set by the relevant call. The regularisation of the transfer must be finalised before publication of the final ranking, according to the timeline in art. 3.

ART. 14 — CHECKS AND PENALTIES

Pursuant to point 12 of Annex A to D.G.R. Lombardy no. 6298/2026 and art. 11 of D.P.C.M. 159/2013, Raffles Milano carries out checks on the truthfulness of the declarations produced by students regarding the economic situation, verifying ALL declarations relating to scholarship recipients. The system of checks carried out by the Revenue Agency, INPS and the Guardia di Finanza remains unaffected.

In the event of untruthful declarations, the penalties provided for by arts. 75 and 76 of D.P.R. 445/2000 apply, as well as those provided for by **art. 10 of D.Lgs. 68/2012**, consisting of payment of a sum equal to **three times** the amount received and loss of the right to obtain other disbursements for the duration of the study programme, subject to the application of criminal law for acts constituting offences.

ART. 15 — PROCESSING OF PERSONAL DATA

15.5 Retention

The data are retained for the time necessary to allow checks by supervisory bodies and the bringing of any appeals, and in any case for no more than 10 years, according to the limitation periods for administrative acts.

15.6 Disclosure and dissemination

The data are not disseminated, except for the publication of the rankings, which takes place within the limits of what is strictly necessary and in compliance with the minimisation principle.

The data may be disclosed to: the Lombardy Region; the Ministry of University and Research; INPS; the Revenue Agency; the Guardia di Finanza; banks for payment management; duly appointed data processors (IT-service providers).

The data are not transferred outside the European Union.

15.7 Rights of the data subject

The data subject may exercise the rights under arts. 15-22 GDPR (access, rectification, erasure, restriction, portability, objection) by contacting the Data Controller at the details indicated. The right to lodge a complaint with the Data Protection Authority (Garante per la protezione dei dati personali) is also recognised.

The provision of data is necessary for participation in the competition: refusal to provide it makes it impossible to process the application.

ART. 16 — FINAL PROVISIONS

16.1 Publicity

This Call is published at <https://rafflesmilano.it/scholarship/> . The deadlines run from the date of publication.

16.2 Legal remedies

Appeals against the measures adopted in implementation of this Call may be brought before the Regional Administrative Court (TAR) for Lombardy within 60 days, or an extraordinary appeal to the President of the Republic within 120 days, running from notification or full knowledge of the act.

For disputes of a non-administrative nature, the Court of Milan has exclusive jurisdiction.
